Representative Projects

Akima subsidiary Talu has provided Initial Outfitting-Transition (IOT) and Initial Outfitting-Commodities (IO-C) services to the Department of Defense as a core business since 2008, completing over 50 projects globally.

National Science Foundation—Our team executed a three-year \$69 million IDIQ for a complete turnkey solution, including providing for FF&E, project management, interior design, transition planning and relocation, and Audio/Visual systems.

Naval Branch Health Clinic, Gulfport, MS—We provided design and outfitting of services for the new 58,000 square foot medical and dental clinic, including the acquisition and installation of furniture, casegoods, medical and non-medical equipment, artwork, and signage. Services included project management, interior design, equipment planning, transition and relocation, warehousing, delivery, installation, equipment testing and training, and disposal and cleanup.

Navy Medical Research Unit, Cairo, Egypt—We contracted for the initial outfitting of three buildings managed by the Navy Bureau of Medicine (BUMED): an animal research lab, an administrative space, and a three-story library and reference building.
